Prices:

Prices displayed on our order form are subject to change without prior notice until an order is confirmed. Once your order has been placed and acknowledged by us, the agreed-upon price will be held firm. Unless explicitly stated otherwise, all prices are **inclusive** of delivery and any applicable taxes or duties.

Payment Terms:

For any orders of Ultracruiser modules or kits, a deposit of at least **35%** will be required to initiate the order process. For lightning build options, a deposit of at least **75%** will be required. The remaining balance for the order will become due **2 weeks** prior to shipping from Hummel Aircraft. We will notify you of the final payment due date. Payment is expected within **3 days** of the final payment request.

We reserve the right to charge interest on overdue payments at a rate of 4% above bank rate from the date the payment became due until it is received in full.

Delivery and Completion Dates:

Any delivery or completion dates provided are estimates only and are based on information available to us at the time of the order. We will make every reasonable effort to meet these estimated timelines. However, we shall not be held liable for any delays caused by factors beyond our reasonable control, including but not limited to supplier delays, material shortages, transportation issues, or unforeseen circumstances. Delays in delivery or completion do not entitle you to cancel your order or claim compensation unless explicitly agreed upon in writing.

Warranty:

Our products are warranted against material defects in workmanship and materials for **6 months** from delivery/completion under normal use. Our only responsibility is to repair or replace defective products or components. This warranty does not cover damage from misuse, normal wear, consumables (unless defective upon delivery), or third-party products (we will pass on their warranties if possible). To claim, notify us in writing within 14 days with proof. You may need to return the item at your expense. Replacements/repairs are covered for the original warranty's remaining term. We disclaim all other warranties, and our liability is limited to repair/replacement, excluding indirect damages.
